ELIGIBLE GIFTS

Alcoa Foundation will match charitable contributions from a **minimum of \$100 per gift**, up to a **maximum total per donor of \$2,500 in a calendar year**. Gifts made prior to 12/31/03 are subject to the previous \$25 minimum and \$10,000 annual donor maximum. All gift matching forms must be received at the Alcoa Foundation processing center within one year of the date of the gift. A personal gift must be paid (not merely pledged) to an eligible school, and may be in the form of a check or marketable securities. Outright gifts of securities will be valued at the **closing** market price on the date of the gift. No other types of gifts will be matched.

INELIGIBLE GIFTS

- Tuition payments or gifts that reduce tuition.
- Gifts that benefit specific individuals, such as scholarship or financial aid.
- Payments for tickets, books, student fees, alumni dues, magazine subscriptions, insurance premiums or other payments which are not direct gifts to an eligible school.
- Gifts made with funds provided to the donor for donation purposes by other persons.
- Gifts made to separately incorporated fund-raising entities such as athletic funds, booster clubs, fraternities and sororities.
- Gifts made by surviving spouses of employees, retirees or directors.
- Value of personal services.

RESTRICTIONS

The matching gift from Alcoa Foundation:

- May not lead to the donor's receiving **any** benefits with a monetary value (such as tickets to athletic or social events).
- May not be used to reduce a church-related financial commitment (such as a tithe or assessment).

THE PROGRAM

The Educational Gift Matching Program is a part of Alcoa Foundation's continuing support for the men and women and the institutions which will provide tomorrow's leadership. The program's principal objective is to provide incentive for Alcoa employees and retirees to make regular contributions to educational institutions of their choice. Under the program, Alcoa Foundation will match an eligible gift to an eligible school. For example, if a donor makes a \$100 gift to a school, the Foundation will make a \$100 gift to the same school. The minimum gift eligible for matching is \$100, and the annual maximum per donor eligible for matching is \$2,500.

HOW IT WORKS

*The donor must fill out the **Top Portion** of this form and send it with the gift to the school. A separate form must accompany each gift. An authorized Financial Officer of the recipient school must complete the **Bottom Portion** and mail the entire form to our processing center so that it is received **within one year** of the date of the gift. Alcoa Foundation may request additional information about the gift from the donor and recipient school. Alcoa Foundation will notify the donor when their matching gift request has been approved. Alcoa Foundation matches gifts quarterly by sending a check directly to the school. The gifts of Alcoa Foundation must be used to advance the educational objectives of the recipient school; beyond that, gifts of Alcoa Foundation are unrestricted.*

The Directors of Alcoa Foundation may revise, suspend or terminate the program at any time. The interpretation and administration of the program will be determined by the Directors of Alcoa Foundation, and their decision will be final.

ELIGIBLE DONORS

- *Active, full-time, U.S.-based employees of Alcoa Inc. or its wholly-owned subsidiaries.*
- *Retirees receiving an Alcoa Inc. pension (other than a deferred-vested pension).*
- *Directors of Alcoa Inc.*

ELIGIBLE INSTITUTIONS

- *Degree-granting colleges, universities and junior colleges qualify if they are fully accredited by a recognized regional or professional accrediting agency and are recognized as tax-exempt by the Internal Revenue Service.*
- *Alumni funds or foundations that exist for charitable purposes may qualify if they are an integral part of an eligible school.*
- *Separately incorporated fund-raising entities - such as athletic funds, booster clubs, sororities and fraternities - **do not** qualify.*
