HOW IT WORKS

At the same time that you make a contribution to an eligible organization, complete the Matching Gift form available in the Forms Catalog on the Compass (Form 75-1890) or from the Foundation staff, and mail it directly to the organization. The match can be made only after your documentation is received from your organization and processed by the Foundation staff. Each gift of \$25.00 or more will be matched dollar-for-dollar. The maximum amount per qualifying donor per calendar year is \$10,000.00. *If the Matching Gift form is received in the Foundation office before December 1 of any given year, it will be applied to your total for that calendar year.*

HOW TO PARTICIPATE

Fill out, sign and submit an Alliant Energy Foundation Matching Gifts form with your gift to the eligible organization (see Part 1 on Page 1). An authorized representative of the organization should then complete and sign its portion of the form and send it to the Alliant Energy Matching Gifts Program at the address on the form along with the requested documentation (see Part 2 on Page 1). Only original forms (with original signatures) will be accepted and processed. Incomplete or illegible forms will be returned to the Donor or Organization.

TRANSFER OF SECURITIES

If your donation represents the transfer of securities, your form must be accompanied with a copy of the transaction notice from your stockbroker (which must clearly reference your name, date and number of shares transferred, and the value of your shares on the day they were transferred). If signing over a stock certificate directly to a non-profit institution (no broker involved), please provide a copy of the authorization letter and/or stock assignment and/or a copy of the front and back of the signed stock certificate, along with the value of your shares on the day they were transferred.

ELIGIBLE PARTICIPANTS

The Alliant Energy Foundation matches financial contributions made by the employees of Alliant Energy and its subsidiaries, retirees of Alliant Energy and its predecessor companies, and members of the corporate Board of Directors.

ELIGIBLE INSTITUTIONS

Charitable organizations holding a current Section 501(c)(3) designation letter from the Internal Revenue Service, fully accredited public or private schools and universities, and instruments of a federal, state or local government as provided by Section 170(c)(3) of the Code all qualify for a matching gift. Copies of state Certificates of Tax Exemption and/or of tax returns are not acceptable forms of documentation. Please see "Ineligible Contributions" below for examples of ineligible institutions. If you are unsure your organization is eligible, please contact the Foundation staff.

Examples of eligible institutions:

- A charitable organization recognized by the IRS;
- A governmental entity in support of a charitable purpose;
- An educational institution located in the United States that holds accreditation appropriate to the level of the school;
- A Fund, Foundation or Association that transmits all contributions directly to an eligible organization.

ELIGIBLE CONTRIBUTIONS

To be eligible for a Matching Gifts donation from the Alliant Energy Foundation, a contribution must be:

- A gift made by an individual person who is an eligible participant (see above) in the program;
- An actual donation, not a pledge;
- Made directly to a qualified and eligible institution or organization;
- Purely charitable; the individual donor cannot receive a benefit or gift as a result of the contribution (i.e., membership dues and subscription or tuition payments, which do not qualify for matching funds);
- A personal contribution by the donor; it cannot come from funds provided by other individuals or groups. For example, in walk-a-thon events, forms must be submitted by each eligible contributor, not pooled by the walker.

INELIGIBLE CONTRIBUTIONS

The Alliant Energy Foundation will not contribute matching funds in these cases:

- Gifts made to religious institutions such as churches, synagogues, temples and other houses of worship, or to any organization whose main purpose is to promote a specific faith, creed or religion and/or direct resources to advocate for a specific ideology;
- Gifts that support political parties or candidates, advocacy programs, or religious, athletic, social or fraternal organizations;
- In-kind donations (the value of personal services or donated materials, goods, etc.);
- Contributions to intermediary ("third party") funding groups whose sole purpose is to raise money to distribute to other charities;
- Donations to United Way, which is already supported by the Alliant Energy family of companies and the Alliant Energy Foundation as a result of annual employee-giving campaigns.

INTERPRETATION OF THE PROGRAM

To assure the Foundation is in compliance with IRS regulations, the Board of Directors has determined that gifts given to athletic programs at colleges and universities will be matched at 80 percent of the amount of the contribution. Likewise, donors who receive a direct personal benefit from their gift (e.g., event admissions, merchandise, membership privileges or discounts) may only request a Matching Gift for the donation amount less the monetary value of any benefits received.

The Board of Directors of the Alliant Energy Foundation is the final authority and reserves the right to determine the eligibility of any match.

SUSPENSION OR TERMINATION OF THE PROGRAM

The Alliant Energy Foundation may suspend, amend, or discontinue the program at any time and reserves the right to determine whether any gift shall be matched.
