Who can receive a Matching Community Gift?

Certified nonprofit organizations are eligible to receive matching gifts if they are not primarily religious or political in purpose, and if their services are available to all individuals on an equal basis. Services sponsored by churches or synagogues are eligible if they meet these criteria.

How much will be matched?

The minimum contribution that will be matched is \$20. Employees may submit up to two contributions to be matched, totaling a maximum of \$50 per employee per calendar year. Only contributions of cash or securities given by employees from their assets will be matched.

How do I get my gift matched?

Employees complete this "Matching Community Gifts Program" form and send it along with their donation to the organization receiving the gift. When the organization notifies ADI that it has received the donation, the company's matching gift will be sent.

Contributions will be credited in the year of matching, which may not coincide with the year of giving.
