



CHARITABLE CONTRIBUTION MATCH
....to encourage and magnify employee generosity.

Information

The Avis Budget Group Charitable Contribution Match Program has been established to encourage employees to support organizations that help others by supplying health, welfare and other life-enhancing services.

Through this program, Avis Budget Group gives employees the opportunity to determine a portion of the Corporation's gifts to charities. Gifts made by eligible employees to qualified charities will be matched on a dollar-for-dollar basis.

Eligible Gifts

Avis Budget Group will match certain independently made employee contributions up to a maximum of \$100 per employee per calendar year. Donations will be applied to the calendar year in which the employee submitted the form to the Answer Place.

The contribution must be made by check or charge. The contribution must be a completed gift; pledges or bequests do not qualify.

Any portion of payment for which the donor receives any form of consideration (subscriptions, tickets, etc.) is not eligible for a matching gift under the Program. In addition, "in-kind" donations (i.e., services) are excluded.

Eligible Participants

At the time of the contribution and the time of the match, the donor must be a United States based active employee of an Avis Budget Group subsidiary company.

Eligible Institutions

The Matching Program is designed to support charities to which Avis Budget Group does not already make a sizable contribution. In addition, Avis Budget Group does not intend to use the funds to support or send a message of any political or religious point of view.

To be considered for a matching gift under the Program, the organization must qualify under Section 501(c)(3) of the Internal Revenue Code.

Not Eligible for Matching Program:

Avis Budget Group excludes from charitable contribution match eligibility:

- Contributions that are made in connection with a major Avis Budget Group sponsored or sanctioned charitable support, organized fundraisers (such as United Way or Inner City Games)

Instructions for Employee

1. Complete the attached form, [including mailing address of the charity and the federal tax id number](#).
2. Provide a copy of the check to the charitable organization and a receipt from the charitable organization. If the donation was made online the confirmation statement will serve as this receipt.
