## **Purpose**

Since its inception, the BAE Systems Matching Gift Plan has provided significant support – through company and employee contributions – to strengthen higher education across the nation.

Building on this tradition, and with a focus primarily on our customer, the Plan is expanding its original focus of support to education, and will also now include support for organizations assisting our Armed Forces and their families, as well as health care and first responder organizations. Providing a one-to-one match, the Plan literally doubles the employee's contribution. This means that the designated organization will receive two gifts – your gift and a gift of the same amount from BAE Systems.

Together, as partners, BAE Systems and its employees are making a difference through their support to expand knowledge, support our customer, increase understanding, and enrich the artistic and cultural expression of the world in which we live.

## **Contributions Guidelines**

BAE Systems will match charitable contributions to eligible organizations made in cash or marketable securities of \$25 or more, to a maximum of \$10,000 per employee per year.

## **Contributions May Not Include:**

- 1. Those made in remission or in lieu of other payments (e.g., tuition, fees, dues, church contributions, insurance premiums, etc.) or in return for any other benefits.
- Those made by a group of BAE Systems employees.
- 3. A pledge for payment not yet made.
- 4. Other payments not regarded by BAE Systems as personal contributions.
- 5. Those made to fulfill membership requirements.

# **Eligible Organizations**

All organizations under the following categories musts be located in the United States and be tax exempt with a 501(c) in their own name or be an instrumentality of a state or local government as provided by Section 170(c)1 of the Internal Revenue Code.

#### **Armed Forces**

Any organization supporting the Armed Forces and/ or their families is eligible for a matched contribution. Gifts may be earmarked for a specific program operated by that 501(c) organization by designating this preference on the line marked "Fund/Purpose" in Part A of this form. The BAE Systems match will be made to the same designation as your gift.

#### **First Responders**

Any agency that is called upon to respond following a national or international disaster, including fire departments and police departments.

#### Education

Any institution that is accredited by the appropriate regional or professional organization. Gifts may be earmarked for a specific department such as the Engineering Department or Business School, by designating this preference on the line marked "Fund/Purpose" in Part A of this form. The BAE Systems match will be made to the same designation as your gift.

Additionally, contributions to minority scholarship funds are also eligible, including the American Indian College Fund, the National Hispanic College Fund and the United Negro College Fund.

Contributions to accredited K-12 school districts are also eligible if your gift is earmarked for use in secondary (high school) education as defined by the recipient.

#### **Health Care Organizations**

This category includes organizations that focus on health, medical research and wellbeing of individuals, including Susan G. Komen Breast Cancer Foundation, American Cancer Society, Alzheimer's Association, etc.

## **Ineligible Organizations**

The following areas of giving are considered ineligible and will not be matched by BAE Systems:

- Religious organizations, to include local churches or religious events;
- 2. Organizations that discriminate on the basis of race, sex, ethnicity, sexual orientation, creed, age, national origin, religion, etc.
- 3. Organizations that decline to disclose financial and management information to the Better Business Bureau;
- Political candidates, parties, campaigns or causes;
- 5. Individuals, regardless of circumstances;
- 6. Labor organizations;
- 7. Fraternal organizations.

Contributions or donations made to Charity Challenge partners are not eligible under this program, as those contributions and donations are eligible for Charity Challenge supplemental funds at the end of each campaign.

# **Eligible Participants**

The Matching Gift Plan is eligible for full-time employees only.

## **Procedures**
