Aid-to-Education Gift Matching Program



FOUNDATION

Purpose

Gift matching is one of several aid-to-education programs sponsored by Harris. It was established to broaden financial support of educational institutions and particularly to encourage employees to contribute to the **colleges and universities** in which they or their families have an interest, and which they feel are worthy of support.

Contributions

Gifts of \$10 or more made by employees to eligible institutions will be matched by contributions from the Harris Foundation to the same institutions, up to a total maximum amount of \$10,000 per individual, per fiscal year of the Foundation (July 1 to June 30). Contributions of securities of known value qualify for gift matching. Gifts must be for educational purposes only (excluded are athletics, radio/TV stations, building funds, tuition, and scholar-ships, etc.).

Employee Eligibility

All regular full-time employees of Harris Corporation and its business segments* are eligible. Donors need not be alumni of the institutions to which they contribute.

Eligible Institutions

U.S., Canadian, and international higher education institutions that grant degrees and two-year colleges whose credits are transferable to four-year degree-granting institutions are eligible for gift matching. All such institutions must be eligible to receive tax-deductible contributions.

(The Foundation necessarily reserves the right to modify or terminate the program.) *Harris business segments include: Broadcast Communications, Government Communications Systems, and Defense Communications and Electronics.
