The EducationDynamics Matching Gift Program provides a way for you to double your personal donations to the American Red Cross. For more information about the Red Cross, please visit www.redcross.org. Within certain guidelines, EducationDynamics will match every dollar you contribute.

Who Can Participate?

Any full-time employee of EducationDynamics is eligible for the program.

When Can I Participate?

The Matching Gift Program currently runs through December 31, 2012.

Eligible Gifts

Each employee has a maximum matching limit of \$5,000, with a \$25 minimum per gift (employee must personally contribute a minimum of \$25). For the gift to qualify for a corporate match, it must be a personal donation given directly to the American Red Cross, in the form of cash (please do not send cash through the mail), check, credit card, or securities having quoted market value. Gifts must be paid, not merely pledged, and given directly to the American Red Cross.

EducationDynamics administers the Matching Gift Program. EducationDynamics reserves the right to amend, modify or cancel this program at any time.

INSTRUCTIONS

1. Employee completes 'Matching Gift Application – Part 1' and sends it with donations to the American Red Cross or makes a donation online via http://american.redcross.org/site/PageServer?pagename=gen_online_emp_pgrm.
2. The American Red Cross completes 'Part 2' to the EducationDynamics Matching Gift Program, within 30 days of the donations, at the address listed in the application or the employee sends the electronic confirmation from the American Red Cross to Andy Stross at astross@educationdynamics.com.
3. EducationDynamics confirms eligibility and then remits the matching gift to the American Red Cross.
