# What is the Dollars for Doers Program?

The support and commitment to local community organizations, from our company, employees and retirees is vital to the mission of improving the quality of life in our communities. If you actively and regularly participate in a community organization on your own time, you can apply for a grant up to \$300 per year. There is a \$1000 maximum cap, for each organization.

Employee and retiree volunteers can receive up to three \$100 Dollars for Doers grants per year. The grants can be for three different projects within the same organization or for three different organizations. Also, a \$300 grant can be requested for one organization.

Applications must be received by **December 1 of each year.** 

### Who is eligible for Dollars for Doers?

- All full-time employees of Eversource
- · All retired employees of Eversource

## What organizations are eligible for a grant?

Qualifying organizations need to be a United States nonprofit with a 501(c)(3) designation by the Internal Revenue Service, or a not-for-profit organization such as public schools or youth athletic groups.

### What organizations are not eligible for a grant?

- Projects benefiting restricted groups (fraternal, politics)
- Religious groups (exclusive of social service activities)
- Team Pledges

### When will my application be processed?

Completed applications will be processed quarterly. Checks will be made out to the recipient community organization and be sent to the employee and/or retiree to deliver to the organization.
