# **EMPLOYEE MATCHING GIFT PROGRAM**

# <u>Guidelines</u>

The Bill & Melinda Gates Foundation will match employee contributions to eligible charitable organizations at a rate of three dollars for every one dollar contributed up to a maximum match of \$30,000 per year (i.e., for employee contributions up to a maximum of \$10,000 per year). The foundation will match gifts of cash, personal checks, and credit cards on a quarterly basis.

Eligible organizations are recognized by the Internal Revenue Service as tax-exempt and designated as public charities under section 501(c)(3) of the Internal Revenue Code (IRC) or are federal, state or local government units as provided by sections 170(b)(1)(A)(v) and 170(c)(1) of the IRC. Examples of eligible organizations include accredited colleges and universities, private and public elementary and secondary schools, public libraries, health and human service agencies, animal welfare organizations and environmental organizations.

The foundation will not match contributions to religious institutions for exclusively religious purposes ; contributions to fraternal or political organizations; payment of membership fees for which benefits are received including memberships in athletic clubs, alumni associations, zoos, parks, museums, and other organizations that primarily benefit the donor; payments that cover the costs of services, tuition, books and student fees; gifts made to donor advised funds or pooled gifts; or payments for raffle tickets, benefits, meals, auctions at (or for) fundraising events, except to the extent the donor did not receive a benefit in exchange for his or her contribution.

# **Application Process**

To request a matching gift from the Bill & Melinda Gates Foundation Matching Gift Program, **eligible employees should complete "Part A**" of this form, sign it and mail it with his or her contribution to the eligible, charitable organization.

An authorized officer at the recipient organization should complete "Part B", read and sign the Matching Gift Agreement and mail the original to the address below. Facsimiles or copies of the signed form cannot be accepted.
