Educational Matching Gifts Program Request Guidelines

The strength and vitality of higher education in America needs the financial support of individuals and the business community. Georgia Power has a strong commitment to higher education, and matching gifts are an important part of this overall program. The purpose of the Educational Matching Gift Program is to encourage employees and retirees of Georgia Power to join the Company in its financial support of higher educational institutions. Georgia Power Foundation, Inc. matches, dollar for dollar, donations made by qualified individuals, up to \$5,000 per year, to the eligible institutions of their choice.

WHO CAN PARTICIPATE

All active full-time, part-time employees routinely scheduled to work at least 1,000 hours each year, retired directors, and retirees of Georgia Power. Gifts from Spouses or Surviving Spouses are not eligible.

ELIGIBLE INSTITUTIONS

Degree-granting graduate and professional schools, universities, two-year and four-year colleges, and technical schools located in the United States that are regionally or professionally accredited, are public charities, and are recognized by the Internal Revenue Service as tax-exempt under Section 501(c)(3) of the IRS Code. Eligible institutions also include alumni funds, foundations, or associations.

WHAT CONTRIBUTIONS ARE ELIGIBLE?

- Personal gifts, from the donor's personal funds, which have been paid and not simply pledged to support the institution's educational objectives.
- The minimum gift eligible for matching is \$25. The maximum amount matched per donor per calendar year is \$5,000. If the donor makes several contributions, gifts will be matched in the order received, up to the maximum limit for the calendar year.
- Gifts must be made directly to approved institutions.
- The donor's yearly limit is based on the date of gift. The completed Educational Matching Gifts Program Request Form must be received from the institution within 120 days of the date of the gift.
- Gifts must be in the form of check or marketable securities with a
 quoted market value. Gifts of securities are valued based on the
 average of the high and low on the date of the gift. No other form of
 personal or real property will be matched.

WHAT IS NOT ELIGIBLE FOR MATCHING?

- Gifts to elementary, secondary, or independent scholarship funds.
- Dues, gifts, or subscription fees to alumni groups, booster clubs or similar organizations whose purpose is other than strict contribution to the institution's educational objectives.
- Gifts for non-scholastic programs, such as athletics (including athletic booster clubs) or stadium construction.
- Payments of tuition or student expenses, pledges, tithes, other church-related financial commitments, or any other legal obligation of the donor.

How the Program Works

BY INTERNET:

BY MAIL:

The donor should:

- Complete Part 1 of the form.
- Mail the original form, with the donation and any other necessary documentation, to the institution of your choice that meets the criteria listed in the guidelines. (Faxed copies will be accepted.) The matching amount provided by Georgia Power Foundation, Inc. will be for unrestricted support.

The authorized officer at the recipient institution should:

- Complete Part 2 of the original application form
- must verify the donation
- sign the application

Eligible gifts are processed and matched to institutions on the following quarterly schedule.

Matching gift requests must be registered within 120 days of the date of payment by check, or traded securities. Gifts registered after that time will not be eligible. All gifts must be verified by the recipient institutions in order to be matched by Georgia Power Foundation, Inc.
