

# **Giroud Matching Gifts Program**

Matching the personal contributions of Giroud Team Members

### What is a Matching Gifts Program?

It's our way of supporting the charitable organizations that you care about. When you make a contribution to a qualified charity, Giroud will match your gift dollar for dollar up \$100.

### Who is eligible to participate?

All Giroud Team Members

### What types of organizations are eligible?

Charitable organizations that are recognized by the IRS as a 501 (c)(3) nonprofit, tax exempt public charity.

### What kinds of contributions are <u>not</u> eligible for a match?

Giroud cannot match donations to:

- Religious, political or fraternal organizations.
- Organizations that discriminate on the basis of race, gender, religious beliefs or other status.

# How do I apply?

There are just two easy steps to apply for your Matching Gift.

- 1. Giroud Team Member: Completes Part A of the attached application.
- 2. Charity:
  - a. Online Donations
    - Forward the charity's donation confirmation to Jeff: <a href="mailto:jgiroud@giroudtree.com">jgiroud@giroudtree.com</a>
    - Or, print-out donation confirmation page from the charity.
    - Email or give the attached donation form to Jeff (be sure to complete your portion, Part A!)
  - b. Donation by Mail or In-Person
    - Mail or give the entire application to the charity
    - Charity completes and signs Part B of the application
    - Charity attaches a copy of the organization's IRS tax exempt letter.
    - Charity sends the entire application and IRS letter to us by December 31st

# When is my contribution matched?

We will process Matching Gift applications as we receive them. A check will be sent to the qualifying charity for the amount given by the employee up to \$100.
