Matching

The Firm will match gifts dollar-for-dollar from a minimum of \$25 to a maximum of \$2000 per eligible individual, per calendar year. The gifts may be made in the form of cash or securities. Contributions can be made to more than one eligible institution.

Educational Institution Qualifications

To be eligible, all institutions must be recognized by the United States Treasury Department as tax exempt under Section 501 (c) (3) of the Internal Revenue Code (the "Code").

Contributions can be made to schools in the United States and Canada provided the schools are recognized by the United Stated Treasury Department as non-profit, non-proprietary educational institutions, contributions to which are deductible by the donor for federal income tax purposes.

Contributions can be made to schools not located in the United States or Canada provided the schools have received a ruling or determination letter from the United States Internal Revenue Service that it is an organization described in Section 501 (c) (3) and 50 (a) (1) of the Code. If this letter is not available, an affidavit or opinion of counsel must be provided setting forth sufficient facts concerning the operations and support of the institution for the IRS to determine that the institution would be likely to qualify as an organization as described in Sections 501 (c) (3) and 509 (a) (1) of the Code. The determination letter, the affidavit or opinion must accompany the Educational Matching Gift Application.

Eligible Institutions:

- Accredited post-secondary institutions listed in the Higher Education Directory.
- Accredited secondary schools listed in the Porter Sargent Handbook of Private Schools.
- State licensed public, private and parochial primary and secondary schools.
- The United Negro College Fund, or independent colleges, or similarly recognized organizations.

Institutions that are not eligible:

- Pre-school
- Childcare

Educational Matching Gift Guidelines

Program Administration

The administrators of the Goldman Sachs Educational Matching Gift Program reserve the right to make the final determination regarding the eligibility of both donors and recipient institutions. The administrators further reserve the right to discontinue or amend any part of the Program without prior notice.

Payments are made on a quarterly basis, on or about the 15th of January, April, July, and October, for applications received by the last business day of the previous month. You should allow time for processing by submitting your gift well in advance of the disbursement periods.

Applications received after the dates indicated above will be processed in the next quarter. For example, an application received on January 1 will be paid in April.

Allow an additional three months for processing applications received from organizations outside the United States and Canada.

Application Procedure

To apply for matching funds, please complete Part A of the application and mail it with your contribution to the eligible institution.

An authorized officer at the institution should then complete Part B and send it to:
