WHAT IS THE HOME DEPOT FOUNDATION MATCHING GIFT PROGRAM?

The Matching Gift Center will process your gift and disburse checks to the eligible organizations on a quarterly basis (April, July, October, January).

WHO IS ELIGIBLE FOR THE MATCHING GIFT PROGRAM?

- All hourly or salary full-time or part-time Home Depot Associates located in the U.S. or Canada
- All Associates on leave of absence located in the U.S. or Canada

WHAT GIFTS ARE ELIGIBLE FOR THE MATCHING GIFTS PROGRAM?

The following gifts are eligible for the Matching Gifts Program:

- □ Individual associate gifts ranging from \$25 to \$500
- Gifts made to organizations that are 501(c)(3) or Revenue Canada designated charities
- Associates' individual contribution to a walk or run in which they have participated. The Foundation will not match gifts that have been pooled. Associates may sponsor other associates in a fitness event, but each associate must complete his or her own form

WHAT GIFTS ARE INELIGIBLE FOR THE MATCHING GIFT PROGRAM?

The following gifts are ineligible for the Matching Gifts Program:

- Gifts to individuals
- Gifts to labor, athletics, social political, veteran, fraternal and religious organizations
- Gifts for fund-raising benefits
- Gifts for dinners, exhibits, conferences and sporting events
- Gifts to charities sponsored solely by a single civic organization
- Gifts for courtesy or journal advertising campaigns

The Home Depot Foundation reserves the right to request a copy of the check, stock or security certificates as proof of the donation. Associates cannot combine gifts with other associates to meet the Matching Gift minimum.
