

MATCHING GIFTS TO EDUCATION PROGRAM

GUIDELINES

Program Description:

The Land O'Lakes Foundation encourages our employees, board members and leadership council members to act as leaders, involving themselves in the financial support of valuable educational institutions and public broadcasting stations across the United States. Contributions made through this program are matched dollar for dollar by Land O'Lakes Foundation.

Program Guidelines:

- Individual gifts from \$25 to \$1,000 per eligible donor per calendar year will be matched. Gifts must be in the form of cash, check or security with a quoted market value. No other forms of personal or real property will be matched.
- Land O'Lakes Foundation reserves the right to change or withdraw this program without notice at any time. The Foundation determines the interpretation and administration of the program's provisions and all decisions are final.

Donor Eligibility:

Eligible donors include the following:

- Full-time and part-time employees receiving Land O'Lakes payroll checks
- Members of the Land O'Lakes Board of Directors
- Land O'Lakes Leadership Council members

Organization Eligibility:

All recipient organizations must be located in the United States and must be tax exempt under Section 501(c)(3) of the Internal Revenue Code.

Eligible institutions include the following:

- Elementary and secondary schools that are fully accredited by the Department of Education
- Public or private colleges, universities, junior colleges, technical/vocational institutes, community colleges and graduate
 professional schools with appropriate regional or professional accreditation, or tax-exempt alumni funds, foundations or
 associations that collect funds exclusively for the direct benefit of an eligible institution
- Public radio and television stations that meet the criteria established by the Corporation for Public Broadcasting

Ineligible Gifts:

Land O'Lakes Foundation will not match:

Application Procedure:

- · Independent scholarship funds
- · Payment for tuition or other student expenses
- Subscription fees for publications
- Insurance premium payments
- · Unpaid pledges

- Special events such as lotteries, marathons, raffles, auctions etc.
- Any donations used to gain preferential treatment from the recipient organization (Example: preferred seating athletic tickets)

Participating donors must complete Part 1 of the application and send the entire application with their contribution to an eligible organization. The recipient organization must complete Part 2 and forward the completed application to the Foundation. Matches are paid quarterly, and donors are notified when the match is completed.
