# MATCHING GIFTS PROGRAM

Lyondell will contribute \$1 for every \$1 contributed by employees of a Lyondell company to a qualified not-for-profit institution.

- The minimum gift that Lyondell will match is \$100.
- The maximum from one individual to all organizations in any one calendar year is \$50,000.

#### **ELIGIBLE CONTRIBUTIONS**

Qualifying contributions include personal gifts from active full-time employees of Lyondell or an affiliate. Personal gifts must not include resources from other people or institutions.

- Contributions must be paid by cash, check, money order, credit card or in securities having a quoted market value.
- For stock and marketable securities, the recipient organization must provide a photocopy of the donor's stock certificate, stock power, and a copy of an official receipt indicating the valuation of the donor gift.

#### **INELIGIBLE CONTRIBUTIONS**

- Memberships.
- Fee for any service.
- Ticket purchases, raffle purchases or auctions.
- Beguests of life income trust arrangements.
- Subscription fees for publications.
- Gifts of real or personal property.
- · Payments eligible for reimbursement.

#### **ELIGIBLE ORGANIZATIONS**

Organizations in the United States must be designated by the Internal Revenue Service as a nonprofit, tax-exempt public charity under Section 501(c)(3) of the IRS code or as a publicly supported charity under Section 509 (a) of the Internal Revenue Code. Institutions affiliated with religious, political or fraternal organizations are not eligible for matching gifts. Other eligibility restrictions may apply.

Organizations located outside the United States must first transmit to Lyondell certification of its charitable intent, a copy of its bylaws, and audited financial statements indicating the amount and percentage of private contributions, governmental support, and any other sources of monetary support.

### **INELIGIBLE ORGANIZATIONS**

- Private operating foundations.
- Alumni Associations.
- Religious, political or fraternal organizations.
- Organizations that discriminate on the basis of race, sex, color or creed.

### INSTRUCTIONS

To apply for a matching gift, employees must fill in Part A of the application and forward this form and their contribution to the nonprofit organization. Part B of the application is to be completed by the recipient organization and returned to Lyondell along with other required documents listed below. Lyondell must receive the completed matching gift form from the institution or organization no later than 90 days after the donor's date of gift.

 A separate form must be completed for each matching gift contribution.

#### **ADMINISTRATIVE CONDITIONS**

For gifts of \$250 or more, an officer of the recipient organization with fiduciary responsibility must provide a brief description of the charitable purpose of the programs of the organization. Payment from Lyondell will include the form "Acknowledgement of Charitable Contribution" which must be returned by the organization, indicating whether Lyondell received any benefits that would reduce the tax deductibility of the contribution.

**For gifts of \$500 or more**, the organization must provide a photocopy of the donor's gift (personal check, etc.) or a copy of the official receipt.

- The nonprofit organization must provide a copy of its IRS 501(c)(3) Tax Determination Letter (first-time requests).
- Lyondell must have on file the organization's nine-digit Employer Tax Identification Number prior to payment of a grant.
- All newly created organizations with an "Advance Ruling Date" that has expired and/or a grace period that has ended will not be matched until the "Final Determination Letter" from the IRS is received by Lyondell.

At its discretion, Lyondell may choose to seek additional information about the purpose of the organization, or the intended use of matching funds, before the matching gift is released. Lyondell reserves the right to determine whether any gift shall be matched and may change, revoke, suspend, or terminate this program at any time. All interpretations of the requirements of this program are solely within the discretion of Lyondell.
