#### **Other News**

<u>General Mills</u> will be reopening their matching program to support Food Security and Sustainability in 2018. Also during the month of November (not starting until 2018) a dollar for dollar match to any 501c 3 including Education & Arts organizations. Stay tuned as more details are released.

Matching gift requests must be submitted for registration within 30 days of the original donation transaction.

All Smucker Employees, retirees, or members of the Board of Directors are eligible to participate.

In the United States:
