IRS regulations do not permit the Open Society Institute matching gift to be used to satisfy a pledge made by an individual. School tuition or fees, subscription fees for publications, dues, payable mileage, or expenses associated with making a donation are ineligible for a matching gift. Other noncash donations (e.g., personal or real property) are also not eligible to be matched under this program.

OSI will match only the charitable portion of a gift. The portion of a gift that represents goods or services received by the employee is not eligible for matching funds. For example, if the cost of a ticket for an event organized by a charitable organization includes a dinner or other goods or services, their value (as determined by the organization) must be deducted from the cost of the ticket in order to determine the amount eligible for matching funds.

OSI matching funds may not be used to carry on propaganda or otherwise to attempt to influence legislation or to influence the outcome of any specific public election or to carry out, directly or indirectly, any voter registration drive. To apply for the Open Society Institute Matching Gift Program, the form on the facing page must be filled out. An eligible OSI employee or trustee should complete PART A of this form and mail it with his or her contribution to the eligible organization. At this time, organizations classified as public charities under Section 509 (a) (3), known as supporting organizations, are not eligible to receive Open Society Institute Matching Gift Funds. By submitting this IRS determination letter, the organization acknowledges that there has been no change in its tax exempt status or classification as a public charity.

OSI will process payment of matching gifts within six (6) weeks of receipt of the completed form. Failure to complete any part of this form or to supply any requested documentation may result in processing delays or rejections.

To encourage private giving by full-time and part-time employees and other members of its Board of Trustees, the Open Society Institute offers a Matching Gift Program under which OSI will donate three dollars for each dollar donated to an eligible charitable organization.

Each eligible trustee or employee may submit a combined maximum of \$15,000 in contributions per calendar year (resulting in a total yearly maximum of \$45,000 in matching funds provided by OSI per eligible employee).

Each contribution must be at least \$50. OSI reserves the right to amend, modify, suspend or terminate its Matching Gift Program at any time.

## **ELIGIBLE PERSONS**

- Trustees of the Open Society Institute
- Full and part-time employees of OSI

### **ELIGIBLE GIFTS**

Gifts may be in the form of cash, checks, or publicly traded securities. Your matching gift form must be received by OSI from the recipient organization within one year after the date of your contribution. OSI will match only actual donations, not pledges. In the case of securities, OSI will only match gifts of publicly traded securities where there is a published bid price. The value of gifts of shares of stocks or other securities will be determined by the last sale of published bid price on the date of the gift.

#### **ELIGIBLE ORGANIZATIONS**

The recipient organization must have a determination letter from the Internal Revenue Service stating that it is tax-exempt under Internal Revenue Code Section 501
