

PRAXAIR MATCHING GRANTS FOR EDUCATION PROGRAM GUIDELINES

The Praxair Matching Grants for Education Program is designed to support Praxair employees who make personal donations to educational institutions. Through this program, you can double your gift to eligible educational institutions. Your donation will be matched on a dollar-for-dollar basis (uP to \$7,500) by the Praxair Foundation.

Who can participate?

Active, full-time Praxair employees in the United States with at least one year seiVice, including those of whOlly owned subsidiaries, and current members of the Prexair bOard of directors are eligibles.

Which institutions qualify to receive matching grants?

Tile program matches donations to institutions trlat ar~ recognized by the internel Revenue Service as tax-exempt under Section 501 (c)(3) of tM IRS code or as an instrumentality of a federal, state or local government as provided by Section 170(0)(1). What gifts are not eligible for matching funds?

- Piedges (onl", gifts almady paid are eiigible)
- Fees for services or tuition payments
- Dues to alumnKaa) or similar groups
- "Donati::ms for primc;lrily political or religious purposes
- .. Gifts that are not personal funds

- Subscription fees for publications
- Beguests of life income trJ.lst arrangements
- Gifts of real estate or personal property
- Gifts from several individuals reported as one donation

What size gift will be matched?

The minimum eligible donation for matching is \$100. Donations may be matched up to a r.laximum of \$7,500 per donor pelt calendar year.

Is there a time limit for matching my donation?

Donation's must be rogistared within ons year of the date of payment by check, credit card or traded securities. All donations must be verified by the recipient institutions in order to be matched. Eligible donations will be matched 8:1d distributed to institutions 1:2 times a year. Applications received by the last working day of the month will generate grants paid by the end of the following month.
