OVERVIEW

1. The Procter & Gamble Fund will match 2:1 a gift in support of an academic purpose at an institution of higher education that meets all of the eligibility requirements detailed in these program quidelines.

- 2. The program operates as follows:
 - The eligible donor completes Part A of the form and mails it to the institution.
 - The institution's Matching Gift Officer completes Part B of the form and mails it to the Fund.
 - The P&G Fund sends both the donor and the institution a letter advising if a match is approved or not.
 - The P&G Fund sends the institution a single annual check in July that matches all requests approved during the current fiscal year from July 1 through May 31.
 - P&G operates on a July 1-June 30 fiscal year, but the P&G Fund closes program records at close
 of business May 31 in order to process the annual checks, letters, and summaries.
 - Requests received in June are held and processed after July 1.
- 3. P&G Fund Trustees may suspend, change or terminate the program at any time. Their decisions regarding interpretation, application, and administration of program provisions shall be final.

DONOR ELIGIBILITY

1. Eligible donors

- Regular full-time P&G employees worldwide. There is no continuous service requirement.
- Regular P&G retirees worldwide who were full-time when they retired.
- Current and retired outside directors of The Procter & Gamble Company.
- 2. Anyone who does not meet the eligibility requirements above is not eligible.
- This includes but is not limited to part-time P&G employees or the surviving spouses of deceased eligible donors.
- 3. A donor may be asked to certify eligibility or gift information.

INSTITUTION ELIGIBILITY

- 1. A U.S. or Canadian college/university is eligible if:
 - It has 501[c]3 tax-exempt status from the U.S. Internal Revenue Service or is operated by the Canadian government.
 - It confers associate, undergraduate, graduate, or professional degrees. If it confers only a degree unrelated to P&G's core business (e.g., theology, war), however, it is not eliqible.
 - A U.S. college/university must also be accredited by one of the six regional accrediting
 associations; select post-graduate higher education programs may be accredited by a national
 accrediting agency recognized by the U.S. Secretary of Education.
- 2. A higher education organization (e.g., UNCF, HACU) is eligible if:
 - It has a 501[c]3 tax-exempt status from the U.S. Internal Revenue Service.
 - Its sole purpose is to raise and transmit tax deductible gifts directly to an eligible college/university for academic scholarships or other academic needs.
 - Each of its member colleges/universities meets all institution eligibility requirements.
- 3. Any institution that does not meet the eligibility requirements above is not eligible.
 - This includes but is not limited to pre-college institutions (high schools, junior high/middle schools, elementary schools, pre-schools, and day care centers) and institutions such as hospitals, radio and television stations, zoos, civic groups, cultural groups, etc.
- 4. An institution may be asked to certify eligibility or gift information.

GIFT FLIGIBILITY

- 1. The minimum eligible gift is \$25 U.S./\$40 CAN. The P&G Fund will match up to a cumulative total of \$5,000 U.S./\$8,000 CAN per eligible donor during any July 1 June 30 fiscal year.
- 2. To be matched, both the donor's gift and the institution's use of the P&G Fund's match must be designated/used for an academic purpose listed as eligible and not listed as ineligible, as follows:
 - Eligible gift designations or uses of the P&G Fund's match include:
 - An academic entity responsible for a curriculum for which students receive academic credit (e.g., College of Engineering, School of Business).
 - An academic entity's campaign to raise money for academic needs (e.g., Law School Annual Fund).
 - A campus-wide fund to raise money for academic needs (e.g., John Doe University Annual Fund).
 - A radio or TV station if it is part of an eligible institution's academic curriculum and the gift is made through the academic entity responsible for it (e.g., College of Communications for WXYZ).
 - An academic scholarship with selection based on merit and/or financial need.
 - A campus library.
 - A class gift or reunion gift used for a specified academic purpose.
 - A capital campaign for an academic need (e.g., classroom building, classroom equipment, library).
 - A campus chapter of an academic honorary. A gift made directly to the honorary's national office is not eligible.
 - A member college/university of a higher education organization.
 - Ineligible gift designations or uses of the P&G Fund's match include but are not limited to:
 - Primary Research (original inquiry, related publications, bench work, etc).
 - A non-academic group, project, program, campaign, or purpose (e.g., campus beautification).
 - An alumni group, including a campaign, publication, or facility benefiting it and/or its members.
 - Athletics, including any related scholarship, program, project, or campaign.
 - A social fraternity or sorority, including any related scholarship, program, project, or campaign.
 - An extracurricular, social, religious, or political club, group, program, project, or campaign.
 - A denominational cause or fulfillment of a church commitment.
 - A donor's dues, social activity fees, subscription, or membership.
 - An individual or an individual's work, tuition, fees, or financial need/obligation.
 - An endowed Chair/Professorship.
 - A donor may not redesignate or resubmit a request for a gift that the P&G Fund has disapproved.
 - The P&G Fund's matching gift is unrestricted. An institution may choose to either use the match for the donor's designation or to use it for another eligible academic purpose.
- 3. An eligible donor may submit a matching gift request for a spouse's gift.
 - The eligible donor must complete and sign the matching gift form.
 - A spouse's gift is debited against the eligible donor's \$5,000 U.S./\$8,000 CAN fiscal year limit.
 - A gift from the surviving spouse of a deceased eligible donor is not eligible.
- 4. A gift must be the donor's personal contribution actually paid to an eligible institution via cash, check, credit card, or whole shares of securities having a quoted market value.
 - A gift may be paid through an eligible donor's charitable fund.
 - The closing price per share on the donor's gift date determines the value of securities.
 - Only the amount paid on a pledge can be matched. It is best to submit a matching gift form with each payment since the Fund must receive the form within one year of the donor's gift date.
 - A deferred gift or planned giving arrangement (e.g., insurance, charitable gift annuity) is not eligible.
 - An in-kind gift (e.g., value of personal property or services) is not eligible.
 - A gift submitted on behalf of an ineligible donor or group of ineligible donors is not eligible.
- 5. A gift must qualify as a charitable donation for income tax purposes.
 - A gift must not directly benefit the donor.
 - The Fund will not match the value of any consideration the donor receives as a result of a gift.
 - A gift in lieu of tuition, books, or other student financial obligations is not eligible.
- 6. The P&G Fund must receive the original matching gift request, with both Part A and Part B fully completed, within one year of the donor's gift date or a match will not be approved.
