## WHO IS ELIBIBLE?

# WHAT IS ELIGIBLE?

• Charitable donations, subject to matching gift rules and caps below.

## **ELIGIBLE ORGANIZATIONS**

Non-profit organizations that align with RMS' ethos and that are certified as tax-exempt by the Internal Revenue Service under Section 501(c)(3) and/or 509(a)(1,2,3) of the U.S. Internal Revenue Code. These organizations are dedicated to:

- Disaster relief (e.g., Red Cross)
- Disaster relicit (e.g.,
  Disaster education
- Disaster preparedness
- Protection of the environment
- Hunger relief (e.g., local food banks)
- Cure of medical diseases/conditions (e.g., Cancer Society)
- Animal welfare (e.g., local humane societies)
- K-12 education (academic programs)
- Higher education (academic departments or the entire institution)

Also eligible for matching employee contributions are non-profit charitable organizations that are actively supported by an RMS client, in the event that a client-facing RMS employee makes a donation to that charity to foster the client relationship.

# **INELIGIBILITY GUIDELINES**

- RMS temporary employees, contractors or consultants.
- Non-monetary contributions
- Any gift that results in a benefit to you or your family (e.g., dinner, sporting event tickets, club dues, memberships, etc.)
- Fundraising events such as raffles or auctions or walk-a-thons
- Political candidates, political campaigns, political parties and other political organizations.
- Religious organizations, such as churches, temples or other houses of worship, whose main purpose is to foster a particular faith or creed
- Fraternities, sororities, honor societies, campus organizations or political organizations

- Tuition of student fees, subscription fees, dues, repayment of loans
- Organizations that advocate, support, or practice activities inconsistent with RMS' equal opportunity and non-discrimination policies, whether on the basis of race, ethnicity, religion, national origin, sex, disability, gender, political affiliation or age.

## All RMS matches are entirely at RMS discretion, and RMS may elect to not match employee contributions to any organization for any reason.

## FUNDING

The minimum matching gift is \$25 for a single transaction. The fiscal year annual maximum amount available for matching is \$500 per employee/\$50,000 in total for RMS. Once the \$50,000 cap is reached, all matching under this program stops.

Matching requests must be received within 60 days of the date of the gift. Matching will be quarterly.
