### Suspended/Discontinued:

[BCE Bell Canada Enterprises](#): No longer matching.

[Cincinnati Bell](#): Program suspended May 1, 2013 due to budgetary reasons.

[Ambac Financial Group](#): Program discontinued April 11, 2013.

[EMC Corporation](#): Program closed due to economic difficulties.

[LM Construction](#): Program closed due to economic difficulties.

[AES and Indianapolis Power & Light](#): suspended program.

[Cephalon](#) acquired by Teva Pharmaceuticals. No known matching gift program.

[West Coast Bank](#) changed name to Columbia Bank and they discontinued their matching gift program for 2013 due to restructuring.

[Wise Foods](#) acquired by Arca Continental in 2012. Matching Gift Program suspended.

[Albertsons](#) is no longer part of Supervalu – it is owned by Cerberus Capital – Cerberus does not have a program.

[Patriot Coal Corporation](#): as of July 9, 2012, and substantially all of its wholly owned subsidiaries filed voluntary petitions for reorganization under Chapter 11 of the Bankruptcy Code. Patriot is using the Chapter 11 reorganization process to make the changes necessary to survive and emerge as a long-term industry participant.

[Océ North America, Inc. and Océ Imagistics, Inc.](#): On January 1, 2013, merged into Canon Business Solutions, Inc., with the newly merged entity being named Canon Solutions America, Inc., a wholly owned subsidiary of Canon U.S.A., Inc. Canon does not have a program that we are aware of.

United States Steel Foundation has enhanced the Matching Gifts Program to simplify the match process and increase the impact of donations to organizations meaningful to you, so that together, we can continue to strengthen our company's commitment to the communities where we live and work.

Instructions for the new online process and requesting paper forms are included in the "How the Program Works" section of the Guidelines, which can be found on the Foundation page. Please note that the paper forms used prior to Jan. 1, 2013 will no longer be accepted due to program enhancements.

Effective March 1, 2013 - New organizations eligible for company match funds

What Has Changed:

In addition to the existing dollar-for-dollar match to higher education institutions, United States Steel Foundation will also match 50 cents for every dollar contributed to eligible organizations within the following categories:

- Private Secondary Education
- Special Education
- Arts & Culture
- Environment
- American Red Cross (within 90 days of an eligible national or international disaster)

*Note: For the categories listed above, only gifts made after March 1, 2013 will be eligible for a match.*

**The maximum amount of company matching dollars per person per calendar year remains at \$10,000 in total.** This amount may be contributed to one or more organizations. The donor's annual limit is based on the date of the gift.

We hope you will consider making a gift to one or more eligible organizations that can benefit from our Foundation's Matching Gifts Program. Thank you for your commitment to our U. S. Steel communities.

Adobe: We recently transitioned to a new system (Your Cause) for Adobe employees to manage their donations and matching grants, and will no longer be connected to our previous vendor JK/EasyMatch. Our new portal does not offer direct access for charitable organizations to confirm donations as that is handled directly through the new system. <http://adobe.yourcause.com>  
Any of the pending requests were approved before the transition.
