The following information is intended to give you updates on programs that have been suspended, changed or needed further clarification:

Suspended/Discontinued:

Ambac Financial Group, Inc.:

Program suspended.

Smith & Nephew:

Per Dave Carlton at the company, the program was discontinued December 31, 2012. They expect to reinstate it in 2014.

ARINC:

Our matching gift program ended as of December 31, 2012, per Linda Hartwig, Senior Director, Marketing & Communications; 410.266.4652

Alcoa:

The Educational Gift Matching Program was discontinued effective December 31, 2012. To be eligible for matching, all gifts must have been made by December 31, 2012 and must have been registered on this website by January 31, 2013.

Viacom:

Offered a special matching gift program for Hurricane Sandy – matching to the Red Cross. The program is now closed.

Goodrich:

- Goodrich Foundation continued to match gifts for full time employees through the end of 2012 via the current process. Next match deadline is September 30, 2012. Match payments will be sent October 2012.
- Eligible employees must submit their final match requests through the online system no later than 12/31/2012 at 5:00 pm.
- Those requests will be paid in Q1 2013 by the Goodrich program.
- On January 1, 2013, all GR legacy employees rolled over into the UTC program, which coincidentally uses the same vendor as Goodrich. Employee interface will be familiar and very similar.

Regence Blue Cross Blue Shield:

The parent company has changed its name to Cambia Health Solutions (www.cambiahealth.com).

Blue Cross Blue Shield of Minnesota:
