The Program

Rohm and Haas Company values the time you spend volunteering in the community and the impact your individual contribution makes.

Established in 1987, Dollars for Doers applauds your community service activities by issuing grants - ranging from \$150 to \$500 - in your name to your favorite non-profit organization.

Any employee who volunteers a minimum of ten hours in any given year with a single organization is eligible for a grant. Whether you volunteer to combat homelessness or illiteracy, to support youth development through athletics or education, or to assist individuals through crisis or illness, your work can earn a Dollars for Doers grant for your organization(s).

The application process

Forms must be processed within three months of the event or from the ending date of period of service. After 90 days the request will not be eligible. Completed forms will be processed and paid on a quarterly basis.

Completed forms will be paid approximately on the following schedule:

Eligible donors

Eligible donors include all full and part-time employees of the Company and its majority-owned subsidiaries. Employees have 90 days past the end of volunteer service date covered by the application to initiate a Dollars for Doers grant.

How grant awards are determined

Grant awards are determined by the number of hours per year you volunteer and the number of years you've been active with your organization(s).

Grants range from \$150 to \$500, depending on the length of service and number of hours volunteered each year.

Employees may earn up to \$1,000 in collective grants (with a maximum of \$500 to any one organization) for the organizations where they volunteer each calendar year. Just one application per year per organization can be made.

A specific organization may earn up to \$1,000 in grants each year through multiple volunteers.

Which organizations are eligible?

All organizations must be located in the United States or one of its possessions and must be recognized by the Internal Revenue Service as tax exempt and designated a public charity under Section 501(c)(3) of the IRS Code. Organizations that are members of or affiliated with a national, state or local organization that hold the 501(c) (3) status that applies to your group are eligible with proof of the 501(c)(3) and membership or affiliation with that organization.

Organizations that have religious, political or labor affiliations must be able to demonstrate that their services are offered non-exclusively to the public.

What organizations are ineligible?

Religious, political or labor organizations that exclude the general public or members of the community from participation in their programs and services are not eligible for a Rohm and Haas grant.
