


Matching Gift Program Donating to the causes you care about.

Have you ever made a donation to a charity and wished you could do more? Well, here's your chance. Even better, it's a chance to double your donation (up to \$7,500) each year! It's all thanks to the Sentry Insurance Foundation, Inc. Matching Gift Program.

ELIGIBLE ORGANIZATIONS

Schools, public broadcasting stations, and disaster relief groups are just some of the organizations that qualify. Eligible groups also include:

- · Accredited colleges or universities
- Primary, secondary, and technical schools; the donation must be
 in support of education through either a 501(c)(3) foundation
 established by a state-licensed or nationally accredited school, a
 school district, or a 501(c)(3) school that has a letter on file with
 the Sentry Insurance Foundation, Inc. verifying that funds will be
 used solely for educational purposes



- Public television or public radio stations that are members of NPR or PBS, or are licensed by an accredited college or university
- Community Foundation of Central Wisconsin scholarships
- · Other organizations:
 - American Red Cross
 - American Cancer Society
 - Alzheimer's Association
 - Boys & Girls Club (Portage or Marathon County)
 - Children's Miracle Network
 - Disabled American Veterans
 - Family Crisis Center (CAP Services)
 - Green Circle Trail
 - Humane Society (Portage, Marathon, Waupaca, or Wood County)
 - Mobile Food Pantry
 - Operation Bootstrap
 - Place of Peace (Stevens Point)
 - Salvation Army

ELIGIBLE DONATIONS

- Your gifts of \$25 to \$7,500 are matched on a dollar-for-dollar basis.
 - Pledges for future gifts are not eligible
 - Gifts for which a service or benefit has been rendered (e.g., tuition, membership, raffle, etc.) are not eligible
- Sentry will match a maximum of \$7,500 each calendar year.
- You may donate to more than one eligible organization.
 - If your total amount exceeds \$7,500, you must indicate how the \$7,500 matching contribution should be allocated
- Sentry's total matching contributions to any single organization are limited to an aggregated annual amount.
 - Contributions exceeding the maximum annual amount cannot be carried over to the following year

HOW TO PARTICIPATE

You must be a full-time or part-time associate or retiree of Sentry Insurance or Sentry Services, a current Board member of Sentry Insurance a Mutual Company, or a former Board member receiving post-service compensation.

Complete Part A and mail the entire form—along with your donation—to the organization of your choice. You can also specify how your money will be used, such as scholarships, building programs, athletics, or fine arts.

The organization will complete Part B and return both parts to the Sentry Insurance Foundation for the matching payment. The Foundation must receive the completed matching gift forms from the eligible organizations within one year of your contribution date.

The Sentry Insurance Foundation, Inc. Matching Gift payments are disbursed semi-annually.
