

# Dollars for Doers Program

## The Program

Each year, you, like so many company employees and retirees, generously give of your time and talents to the community. A financial grant from Wisconsin Public Service Foundation can make those worthwhile volunteer hours even more valuable.

The foundation's Dollars for Doers Program donates up to \$100 per year on behalf of employees and retirees who volunteer 20 or more hours in a fiscal year.

## Who Can Participate?

The Dollars for Doers Program is open to employees and retirees of:

- Integrys Energy Group, Integrys Energy Services, Integrys Gas Group and Integrys Business Support (except employees and retirees in Illinois; please call 312-240-4930 for information about Illinois)
- Michigan Gas Utilities (all employees, and those who retired on or after July 1, 2006)
- Minnesota Energy Resources (all employees, and those who retired on or after July 1, 2006)
- Upper Peninsula Power Company
- Wisconsin Public Service

## Eligible Organizations

If you volunteer for organizations in the categories below, they may be eligible for Dollars for Doers funds. Organizations need to operate in the company service area where you live or work. They must also be tax-exempt under Section 501(c)3 of the Internal Revenue Code.

### Eligible categories:

- Arts and culture
- Community and neighborhood development
- Human services and health
- Environment

## Ineligible Organizations

Because our companies have so many opportunities to give, and limited funding, we are sorry to say we cannot support contributions to these types of organizations at this time:

- Educational institutions
- Civic groups, including fraternal, social, union or veteran organizations

- Religious or political organizations
- Organizations whose philosophy and mission conflict with company positions
- Private foundations
- Gifts to individuals
- In-kind gifts

## To Participate

Wisconsin Public Service Foundation will donate up to \$100 per year to a qualifying nonprofit organization. If you volunteer 20 hours or more per year for more than one qualifying organization, you can request a 50/50 split of the \$100 between two organizations (\$50 to each organization).

Your volunteering must be done on personal time. Board meetings, committee meetings and fundraising projects during your normal work hours are not eligible for Dollars for Doers.

To request Dollars for Doers funds:

1. Complete Section A on the reverse side of this sheet and mail it to the eligible organization. *The deadline for submitting the Dollars for Doers form is December 1 of each year.*
2. The nonprofit organization should complete Section B and return the form to the Dollars for Doers Program coordinator.
3. After receiving the completed form, the program coordinator will verify the eligibility of the organization and the volunteer hours

*Dollars for Doers Program Administration: Wisconsin Public Service Foundation sets aside a maximum annual contribution level for the Dollars for Doers Program. After this contribution level is reached, no further funding is available. The Dollars for Doers fiscal year ends on December 1.*

*The foundation reserves the right to amend, suspend or terminate its Dollars for Doers Program at any time without prior notice.*
