# Eligible Donors:

Regular full-time Yum! Brands employees and directors of the corporation. Eliaible Institutions:

All institutions or organizations must be located in the United States and must be recognized as tax-exempt by the Internal Revenue Service under section 501(c)(3) of the Internal Revenue Code.

### Administrative Conditions:

Donation Minimum: \$25 / Annual Maximum per employee: \$10.000

Contributed amounts are applied toward the annual maximum for the year in which they were paid by the donor. Once a donor reaches the maximum contribution amount in any given calendar year, no further matching contributions will be made for that donor for that year.

#### **Restrictions:**

- The Yum! Brands Foundation must be in receipt of the completed form within six (6) months of the date of the gift to be eligible for a match, and must be received by the Yum! Brands Foundation no later than December 1 in order to be considered for payment in the current calendar vear
- The Foundation may suspend, change, or terminate this program at any time, for any reason, and shall determine the interpretation, application, and administration of the program, and its decisions shall be final
- Under certain circumstances, the Foundation may, in its discretion, match larger gifts by eligible individuals
- It is the intention of the Foundation to disburse matching gifts to recipient organizations on a period basis; however, the Foundation makes no representation as to when gifts may be matched

### Not eligible for match:

- Lower and higher educational institutions
- Group gifts combining donations from several individuals (i.e. funds collected from Yum! or non-Yum! employees for a charity walk and submitted on one form by a Yum! employee
- Subscriptions, tickets, memberships or tables at fundraising events
- Contributions to organizations that exist primarily for political or religious purposes including church capital campaigns and building funds
- Gifts to fulfill unpaid pledges
- Insurance premium payments, tuition payments, beguests or legacies
- Contributions to organizations that might pose a conflict with
- Yum! Brands' mission, programs, products, services or employees
